In the case of land you have held for years prior to Tender acceptance, you are required to obtain an up to date Sect.149 from council for our review please. We also require written evidence as to the current <u>ownership of the land</u>, this can be in the form of a current rates notice or letter from your solicitor confirming the settlement details of the purchase of your property.
- A "Schedule of Finishes" template.

 Note: With your DA application council will require a schedule of the external finishes i.e. colour scheme/type of finish. Attached is an example together with a description of what is required at this stage.
- Please advise of any specific notes you would like for us to include in your (S.O.E.E)
 Statement of Environmental Effects?
- Receipt of the initial deposit, being a payment of \$ 8,000.00 as detailed on the last page of our tender document. See overleaf for details of payment methods.

This will allow us to commence with the items outlined in the attached (HIA preliminary agreement form).

In addition to the above items which are included in our tender, we may be required by the Council/Certifying authority to engage additional consultants, e.g. Tree Arbirost report, Bushfire report, Geotech Engineer (landslip report), to form part of our complete DA submission. In this regard, where necessary we will obtain fee proposals on your behalf, for your assessment & direct engagement.

2) I/WE AUTHORISE AND REQUEST YOU TO:



- a) Arrange a site inspection of the land.

- d) Preparation of a Statement of Environmental Effects (S.O.E.E.) and Shadow Diagram.

- f) Arrange for the preparation of engineering design for the building works on the land, including Borehole report and Site Classification.

Total Price (GST inclusive): \$8,000.00

- 1) I/We agree to pay the contractor the total price. This is payable prior to commencement of the above works.
- 2) I/We acknowledge and agree that the property and ownership and the copyright of all plans, sketches and designs prepared by the contractor in accordance with this agreement shall remain the property and the ownership of Tullipan Homes Pty Ltd at all times and nothing in this agreement shall give a license or otherwise to the owner to use any plans, sketches or designs prepared by the contractor.
